#### b. Vehicle Procurement

Background: Coos County Area Transportation District (CCAT) was awarded Agreement 35416 5311 Grant in the amount of \$251,808 (grant \$226,628 and match \$25,180) to replace bus 101 and backfill the Gilliam County vehicle that was on loan to CCATD for 6 years. On 2/27/2025, CCAT sent Request for Quotes (RFQ) to all vendors on the State Price Agreement asking for two vehicles with seating for up to 16 passengers and 2 wheelchair stations. A due date of 3/16/2025 was established with an extension 4/4/25. Four responses were received. The funding needed to augment agreement 35358 in the amount of \$91,336 is available through STIF and sale of old rollingstock.
