#### 7. OLD BUSINESS

#### a. Wage/Benefit Update

After interviewing staff and getting feedback on various benefit options and further consult with our insurance broker, Metz recommended that CCATD not institute a group health insurance policy but a taxable Health Insurance Stipend. This reduces the cash flow barrier to participating in the Health Insurance Marketplace and provides the most flexibility on choice of plan.

**Motion:** Director Taylor moved to adopt the Health Insurance Stipend Policy as presented. Director Kelly Irvin seconded. Passed unanimously.

**Motion:** Director Taylor moved to institute a \$430 Health Insurance Stipend for 2022. Director Kelly Irvin seconded. Passed unanimously.

#### 8. NEW BUSINESS

a. Trading the Trolley for Another Bus.

As the Trolley is not supported mechanically in this area while under warranty and the District does not have sufficient CDL drivers to drive the vehicle, the General Manager is seeking a consensus from the Board to seek out another Transit provider to initiate a trade or sale in rolling stock. The Board agreed that if CCATD could find a way to trade it in for another transit vehicle to go ahead and move forward with a sale.

Jennifer Boardman informed the Board that because the Trolley was purchased with federal funds that anything over \$5,000.00 must be approved by ODOT & the FTA. Usually, they allow you to reinvest that money into another vehicle. However, trading the Trolley CCATD wouldn't need prior approval.

**Motion:** Director Johnson moved to approve selling the Trolley or trading in the Trolley for another transit vehicle. Director Dovenspike seconded. Passed unanimously.
