Jane Stebbins reported that she went to the SDAO Conference in February. Some of her highlights are the following:

- Board Members are going to be required to start attending at least one training session per term.
- Procurements numbers are changing. The Low level, requiring no comparison, is increasing from \$10,000 to \$25,000. The Intermediate level, requiring comparison of bids, is increasing from \$150,000 to \$250,000. Anything over that still requires the full RFP process.
- They've set up a new corporation, known as a B-Corp in other states, that would allow a company to get preference when looking for contracts.
- The OR Government Ethics Commission can now investigate complaints about public meetings being mishandled.
- There is a new option for calling executive sessions, allowing sessions to discuss safety measures to protect the Board and Staff, as well as cyber security purposes.
- They have added into Oregon law that serial communication, usually via email, is not allowable. If you are going to be talking to another Board member about any business for CCATD, don't discuss it unless in the public meeting.
- Oregon says that special districts can be sued if the correct steps are taken. This excludes contracts and some property items.
- Boards are responsible for policy, financial and legislative oversight, and they handle that by being the overseer of the General Manager.

c. Coos Transit Center & Mobility Hub

Background: Coos County Area Transportation District (CCATD) currently operates on a .44 acre lot which is inadequate for the present fleet size and does not allow for future growth. As part of an overall plan to improve services and facilities, CCATD requires a new Administration/Operations & Maintenance facility to service the fleet with a companion multimodal transfer hub for maximum efficiency and safety estimated at 1.5 acres.

AC Motion: **Harper Thompson** moved to recommend the CCATD Board of Directors support the work of staff to improve CCATD services and facilities through the development of a Transit Center & Mobility Hub in Coos Bay/North Bend. **Steve Zehler** seconded, and the motion passed unanimously.

AC Motion: **Steve Zehler** moved to submit a letter of support to the Board of Directors. **Harper Thompson** seconded, and the motion passed unanimously.
